In the circumstances stated above, following promotion, transfer and postings are ordered with immediate effect.

1. Sri. K. S. Pradeepkumar, Junior Superintendent, working on temporary Post shifting basis at District Insurance Office, Thiruvananthapuram is transferred and posted in the District Insurance Office, Kollam, considering his request in the existing vacancy arisen due to the promotion by transfer of Sri. V. Vasanthakumaran, Junior Superintendent. He is not eligible for TA and joining time.
